## Point 1.

The different evaluation panels carefully reviewed the evaluation criteria established in the call notice, as well as the reasons for conflicts of interest established by FCT. Individual declarations of conflict of interest are attached.

## Point 2.

After the application deadline, all candidates were notified to complete their application by submitting any missing documents. The evaluators panels then reviewed the eligibility requirements and examined the submitted documents. This process was conducted in accordance with the notice published on the EURAXESS platform on November 24th, 2023, which was available in both Portuguese and English. The review process was also conducted in accordance with the Foundation for Science and Technology's Research Grants Regulation.


